I agree to indemnify The Montpelier Foundation and the National Trust for Historic Preservation and to hold them harmless against any claims of unauthorized use (including without limitation copyright infringement claims and royalty or fee demands) and the costs and expenses of any legal action arising from my use of the image(s).

Appendix A:

Conditions for Reproduction Rights

1. Images from the collection of The Montpelier Foundation and National Trust for Historic Preservation collection overseen by The Montpelier Foundation may not be reproduced without the express written consent of The Montpelier Foundation.
2. Requests for permission to reproduce an image must be made in writing on a fully completed Application for Reproduction Permission (application form attached).
3. If requested, reproduction fees are payable in advance whether or not the image is used. If the image is not used, reproduction fees may be refunded in the discretion of The Montpelier Foundation upon receipt of a written request.
4. Upon payment of reproduction fees (if applicable), signed approval of an Application for Reproduction Permission form constitutes permission to reproduce on the terms specified in the approved Application and these Conditions for Reproduction Rights. All other rights in the images are reserved to The Montpelier Foundation and (where applicable) the National Trust for Historic Preservation. Without limitation, neither The Montpelier Foundation nor the National Trust for Historic Preservation surrenders the rights to publish the image(s) itself and to grant others permission to publish the image(s).
5. Permission will be for ONE-TIME NON-EXCLUSIVE USE solely for the “Planned use of image(s)” specified in the approved Application. Any other reproduction or use of the images is prohibited without the express written permission of The Montpelier Foundation and the payment of additional use fees. The person to whom permission is granted is not authorized to delegate or grant permission to any other person.
6. Only images furnished directly by The Montpelier Foundation are authorized for reproduction.
7. Each image must be reproduced unaltered and in its entirety unless changes are approved in writing in advance by The Montpelier Foundation. The image may not be cropped, bled off the page, printed on color stock or with ink in colors different from the original, have anything superimposed on it, or otherwise be altered in any way. If use of a detail is approved by The Montpelier Foundation, the word “detail” must appear in the caption/credit line.
8. Image must be credited without abbreviation as specified in the approved Application, and the credit must appear in immediate proximity to the image or in the section of the publication devoted to photographic credits. The standard credit line for images from The Montpelier Foundation collections will say “Courtesy of the Montpelier Foundation, James s Madison’s Montpelier.” The standard credit line for images from National Trust for Historic

Preservation collections overseen by The Montpelier Foundation will say “Courtesy of Montpelier, a National Trust Historic Site.” If the image is of a photograph by a known photographer, the name of the photographer will precede the credit line (“Photograph by ___”).

9. If the image is to be reproduced with a caption that does more than merely identify the image, The Montpelier Foundation reserves the right to approve the caption before publication.

10. All materials containing images are the property of The Montpelier Foundation, and they must be returned to The Montpelier Foundation by the date specified in the approved Application. In the case of electronic images, where specified, each person to whom an image was provided must send written confirmation to The Montpelier Foundation that the person has deleted all copies of the images from its systems and arranged for deletion from the systems of anyone that directly or indirectly received the image from the person. Fees will be charged for late return of the material and late confirmations of deletion, and a replacement charge will be imposed for the loss or damage of borrowed material.

11. The Montpelier Foundation reserves the right to deny permission to reproduce an image for any reason or for no reason. 12. The Montpelier Foundation will make reasonable efforts to inform persons requesting reproduction rights of copyrights and other restrictions that may apply to an image for which permission is granted. Each person to whom reproduction permission is granted agrees to indemnify The Montpelier Foundation and the National Trust for Historic Preservation and to hold them harmless against any claims of unauthorized use (including without limitation copyright infringement claims and royalty or fee demands) and the costs and expenses of any legal action arising from such person’s use of any image furnished by Montpelier.

13. Upon print publication, each person to whom reproduction rights have been granted must provide The Montpelier Foundation with at least one complimentary copy of the publication (or appropriate tear sheet) in which the reproduction appears.
